TERMS AND CONDITIONS

By accessing or participating in the Sizzle & Win Lucky Draw Campaign (the “Contest”), you agree to these Terms and Conditions. If you do not agree, please do not participate.

1. Organizer and Eligibility

1.1. The Contest is organized by QB Food Trading Pte Ltd (the “Organizer”).

1.2. Open to all Singapore residents except as outlined below.

1.3. The following individuals are ineligible:

- Employees of the Organizer or its affiliates.
- Representatives, employees, agents, and service providers of the Organizer.
- Immediate family members of any of the above (spouse, children, parents, siblings).

2. Contest Duration

2.1. Contest runs from 1 December 2024, 12:00 AM to 31 January 2025, 11:59 PM (“Contest Period”).

2.2. The Organizer reserves the right to amend the Contest Period without prior notice.

3. How to Participate

3.1. Eligible Contestants must register on the official contest website within the Contest Period.

3.2. Required information:

- Name, email address, and phone number.

3.3. Upload a purchase receipt from any participating merchant. Receipts must clearly show:

- Merchant name and address.
- Purchase date and time (within the Contest Period).
- Total receipt amount.
- Specified items and amounts spent (per campaign mechanics).

3.4. Qualifying spend and raffle entries:

- A minimum spend of S\$20 on eligible items is required to participate.
- For every S\$20 spent, participants are entitled to 1 raffle entry (e.g., S\$100 purchase = 5 entries).

3.5. Receipt images must meet quality standards; blurry or unclear submissions will be disqualified.

3.6. Prizes are non-transferable and awarded “as is.” Substitution of prizes is at the Organizer’s discretion.

3.7. Winners will be contacted via the provided email and phone.

4. Prizes and Redemption

4.1. Lucky Draw Prizes:

- Weekly Draw: 10 Breakfast Makers per week.
- Consolation Prizes: 4 Basket Air Fryers per month.
- Grand Prize: 1 Smokey Blue Padova Cookware Set per month.

4.2. Draw Schedule:
